



# Exploring Pretrial Justice: Community Workshop

February 9, 2021

## Course Overview

Welcome to Exploring Pretrial Justice! This five hour class will take a look at the front end of the criminal legal system, including its history, structure, decision points and current controversies. This is ideal for organizers, volunteers, advocates and interested community members looking for a better understanding of how the pretrial system works. In addition to the five hour live class, participants will have access to reading materials and resources through the University of Pretrial.

## Learning Objectives

By the end of the class, you will:

- Explore the history of pretrial justice through racial lens;
- Investigate and explain the roles and power of system stakeholders;
- Articulate and illustrate history's influence on present day practices and policies;
- Analyze current controversies in pretrial decision making; and
- Identify next steps for pretrial system improvement in your own work.

In addition, Zaria has worked with various initiatives to support higher education access for those currently and formerly incarcerated. She is passionate in her community advocacy in the areas of pre- and post-incarceration reform.
